Determining Which Clinic & Insurance is Right for You

HIV care, including the cost of medications, will be no cost for you. Clinics can work with you to help with your long-term insurance needs as below:

1. Residency: Where do you live? (To verify eligibility)

- **LA resident** (including homeless in LA)? If yes, **continue to question #2**.
- **Lives outside of LA**. Call the Rapid and Ready Navigation Team* for assistance.

2. Do you have insurance? (To verify eligibility)

- Yes**
- If **Medi-Cal** in LA, call a RAPID provider who accepts **Medi-Cal**.
 - If **Medicare** in LA, call a RAPID provider who accepts **Medicare**.
 - If **Kaiser**, Call the Rapid and Ready Navigation Team* for assistance.
 - If **private insurance (Covered CA or employer sponsored)**, consider clinics that accept some private insurance plans (call ahead to check on your specific plan) or call the Rapid and Ready Navigation Team* for assistance.

No If no, to determine long-term insurance eligibility, **continue to question #3**.

3. What is your income?

No Income

- If **NO income** (ex. just lost job), then **Medi-Cal eligible** or *can* be covered by the **Ryan White HIV/AIDS Program**.

Low Income

- If **LESS THAN \$18,768/year**,^{1,2} then **Medi-Cal eligible** or *can* be covered by the **Ryan White HIV/AIDS Program**.

Income over Medi-Cal threshold (\$18,768/yr)

- If **MORE THAN \$18,768/year**^{1,2} and **BELOW \$69,750/year**³, then **Ryan White HIV/AIDS Program** may be a good fit.
- If **ABOVE \$69,750/year**³, may need to attain **private insurance (Covered CA, employer sponsored, or Kaiser)**

***How to Call the Rapid and Ready Navigation Team: (833) 351 - 2298**

1. Based on 2022 Income Eligibility Requirements. See <https://dpss.lacounty.gov/en/health/adults.html> to verify.
2. Pre-tax gross income for a household of one. See <https://dpss.lacounty.gov/en/health/adults.html> for larger households.
3. Based on 2022 Federal Poverty Guidelines. Amount is 500% FPL for a household of one. See [CDPH site](#) for larger households.
