

#### Los Angeles County Domestic Violence Council General Meeting 900 S. Fremont Ave., Room C Alhambra, CA 91803

## Minutes of September 18, 2018

## 1. Introductions/Announcements

The meeting was called to order by Executive Director, Eve Sheedy at 12:01 p.m.

Eve Sheedy introduced herself as the new Executive Director and invited attendees to introduce themselves.

Ms. Sheedy announced that the transition of the Domestic Violence Council (DVC) to the Department of Public Health is underway. Future projects include a revised website and an online calendar. Ms. Sheedy encouraged attendees to contact her or her assistant, Jolene Cooper, for questions or concerns.

# 2. <u>Update/Comments from Executive Director</u>

Ms. Sheedy discussed some focal points of the DVC going forward, including how to increase the voice of survivors, how to use data to inform DVC practices, and how to make structural changes to better serve the DVC and the community. She urged everyone in the coalition to work together and provide input to shape the DVC in this new journey and reminded everyone that this is a work in progress.

Additionally, Ms. Sheedy reflected on the transition to Public Health and the perspective of seeing domestic violence through a trauma lens instead of a criminal lens. She emphasized assessing the needs of individual communities and working together toward a whole spectrum approach.

#### 6. <u>Presentation: "Addressing Domestic Violence as a Public Health Issue"</u>

#### Presenter: Dr. Deborah Allen, Deputy Director Health Promotion, Los Angeles County Department of Public Health

Dr. Allen provided her vision of approaching domestic violence from a public health perspective. The first step is assessment, which involves defining, measuring/counting, and gathering data. The next step is policy and program development. The last step is assurance—evaluating and monitoring results for the desired outcome. Dr. Allen discussed Public Health's goals for

prevention and creating a healthy climate for interpersonal relationships within all social dimensions.

# Presenter: Dr. Susie Baldwin, Medical Director, Office of Women's Health, Los Angeles County Department of Public Health

Dr. Susie Baldwin provided an overview of how the public health approach impacts domestic violence survivors. She noted that the goal of public health is to advance population health and prevent unhealthy behavior by looking at the whole picture and finding long-term solutions. By contrast, the criminal justice approach offers a closed-end solution revolved around courts and punishment. Dr. Baldwin then explained the social-ecological model for violence prevention and the transtheoretical model of health behavior change, or stages of change, that impact survivors.

# Presenter: Nicolle Perras, MA, MPH, Research Analyst III, Injury and Violence Prevention Program, Los Angeles County Department of Public Health

Nicolle Perras provided an overview of the Injury and Violence Prevention Program (IVPP) and how its work affects domestic violence. She referenced several programs related to violence reduction, such as the Trauma Prevention Initiative, Safe Passages, and Parks After Dark. She discussed how IVPP initiates community engagement, street intervention, peer navigation teams, and trauma informed care.

# BREAK-OUT SESSION: SUMMARY OF "GOALS OF THE DVC" DISCUSSION

#### General

Reduce/eliminate/prevent domestic violence.

To improve the lives of those experiencing IPV in LA County.

#### Structure

Create cohesiveness / standard of services and care across access to services by survivors.

Best practices / share / collaboration

Networking of service providers (know what other providers are doing)

Data

Because of size of LA County, need communication path so information can be shared, especially to see trends coming in sync with public health approach.
