Los Angeles Regional Policy Committee Meeting Thursday, January 17, 2019 City Hall Room 1070 10:00 to 11:30 a.m.

Introductions and Welcome by Co-Chair Nancy Volpert

- Welcome to members of the newly reconfigured Regional Policy Committee.
- Review of legislative calendar. Anyone who is interested in gaining access to the legislative chart (a Google Doc) should contact nvolgenteenstrukture.com.

State Legislation:

- Update on Governor Newsom's January Budget proposal impacts on domestic violence survivors and service providers. Discussion of possible legislation addressing expanding definition of DV to include economic abuse, frivolous litigation, treating courthouses as sensitive locations and payment for sexual assault exams.
- Discussion about AB122, human trafficking multi-disciplinary team, removes informed consent requirements if the impacted individual is a minor. Several concerns raised, is this about child abuse, can minor's make their own consent, could this be used to access custodial parent's information, etc. Being discussed with CPEDV, requesting amendments to protect rights and conform with VAWA.
- Request to all participants to send information regarding potential bills of interest to Minty and Nancy before Feb meeting.

Review of Federal Legislative issues:

• Federal shutdown impact, background checks being delayed. Discussion of U-Visas. Reminder that Section 8 residents cannot be evicted from housing for non-payment of the federal portion of rent.

Review of Local Issues:

• The Mayor's Office is working on an updated LA City Homeless Policy/Strategy. DV issues were raised in stakeholder meetings and hopefully will be incorporated in updated strategy.

Networking/Breakout

Questions discussed: What data should we collect? Who should we collect data from?

- Recidivism
- Efficacy of BIPs
- What data are other DV agencies collecting (probably inconsistent) and <u>how</u> are they collecting?
- What do agencies ask about gender identity or sexual orientation?
- How are agencies assessing aggressor vs. survivor?
- How do we ensure data is not skewed?
- How do we survey without creating long intake processes for survivors?
- Data on how survivors found out about DV services
- Impact of DV on disabilities and vice versa
- Prevalence of DV in LA county households, how many had to leave home because of DV, homelessness
- What does success look like to survivors, e.g., what is a successful housing outcome for a survivor?
- Legal issues faced by survivors (employment, housing, etc.)
- Services available for underserved communities (e.g. transgender) and what is the best way to get the word out in the community
- Need to be careful about how survey questions are written—use trauma-informed way
- Need NNEDV-type census survey but only for LA county
- Elder abuse in South Asian community
- Longer term outcome data from client we cannot contact, so maybe across DV victims served by shelters/
- Types of abuse emotional, financial, sexual, physical, neglect—ask questions that describe actual abuse. "Does your partner restrict your access to funds?"
- What about "normalized abuse?"
- Children's grades as related to IPV households (loss of productivity in society)
- Measurement of DV among teens—Is it related to generational trauma?
- Include dorms, nursing homes, prisons, public health clinics
- Include universities and colleges
 - What are the barriers?
 - Did they make attempts to get help? Police, doctors, etc.?
 - What was the response? Breakdown...restraining order,
 - What led to them getting the services they are getting?
