Minutes of April 16, 2019

1. <u>Announcements and Introductions</u>

The meeting was called to order by Executive Director Eve Sheedy at 12:05 p.m.

2. <u>Approval of Previous Minutes</u>

Ron Geltz made a motion to approve the February 2018 minutes and was seconded. The motion carried with no nays or abstentions. Ron Geltz made a motion to approve the March 2018 minutes and was seconded. The motion carried with no nays or abstentions.

3. <u>Update/Comments from Executive Director</u>

Ms. Sheedy reported the following updates:

- Los Angeles County Department of Human Resources released an internal training video about Domestic Violence Awareness, and it has already garnered 15,050 views.
- The Los Angeles County Department of Public Health (DPH) is creating an Office of Violence Prevention.
- The County and DPH have a commitment to addressing DV that goes beyond the DVC. Other offices, including the Office of Women's Health (OWH), have been and continue to work on the issue. The County is dedicated to raising the profile of DV and providing support and services.

4. <u>Immigration Update</u>

- Processing for VAWA and U-Visas may take additional 6 to 7 months. There is an increased risk of removal to survivors whose U-Visa applications are denied. Accordingly, practitioners have to consider the risks of removal when providing advice to survivors.
- Public charge is still pending. Clients should still apply, but contact an agency for advice on a case-by-case basis due to greater risk of removal.
- Withdrawal of U-Visa petition triggers possibility of removal proceedings.

5. <u>Presentation: Creative Interventions</u>

Speaker: Mimi E. Kim

Creative Interventions & California State University, Long Beach

Dr. Kim provided an overview of her work and her organization, Creative Interventions. She discussed addressing DV within the criminal justice system, why that occurred and the impact it has on people of color and others. She discussed moving responses to DV out of the criminal justice system through the application of restorative justice and other models. She also engaged attendees in a storytelling experience of a domestic violence

survivor and split into small group discussions to explore the issues raised. People accompanying Dr. Kim discussed their organization called "Survived and Punished."

The presentation was followed by a brief question and answer period.

2019 Legislation: Federal

The presidential budget has been put out; Congress does not necessarily adopt, and has not done so in decades; Congress controls the pursestrings. Negotiations continue.

Three competing VAWA bills, support and thanks to Karen Bass for co-authoring (1) VAWA reauthorization bill with minor improvements, with new majority in house, there is hope for this bill; the other two versions are (2) VAWA straight renewal and (3) stripped down VAWA with protections for indigenous and LGBTQ victims stripped out. Hannah reminds us that while VAWA is usually bipartisan legislation, allowing us to direct energies elsewhere, this year is deserves attention and should not be taken for granted.

2019 Legislation: Local

Level funding for next year at \$5M; today is last ConPlan meeting and yesterday was last day to comment on Measure H funding; County has approved an Office of Violence Prevention within the Bureau of Health.
