 - 5. AB 67 is moving, next hearing on 8/12/19, but it is still unclear how requirement to participate would work with VAWA confidentiality
 - 6. AB 166's next hearing date is 8/12/19; allows MediCal to provide services for hospital based intervention services; expected to pass
 - 7. AB 171's next hearing date is 8/12/19
 - 8. AB 196 is now a 2 year bill
