- I. Eve Sheedy, DVC Executive Director, called the meeting to order at 12:03 p.m. She introduced herself and asked attendees to introduce themselves in the chat.
- II. Ms. Sheedy reported these updates:
 - a. In Los Angeles County, COVID-19 vaccines are now available to anyone ages 12 and older, and walkups are available.
 - b. The UCLA Pritzker Summit on Child Welfare and Domestic Violence took place last week. The Pritzker Center also published a white paper on the subject. It is posted on the *Research* page of the DVC website. The Ad-hoc DV/Child Welfare subcommittees will wrap up by the end of July, and Eve will report their findings.
 - c. The DVC is regulated by the Brown Act and its restrictions regarding remote meetings. The current emergency provisions allowing remote attendance will expire, but proposed legislation is pending to continue the options for remote meetings.

- IV. Sandy Benitez, Coalition for Humane Immigrant Rights of Los Angeles (CHIRLA) presented an immigration report.

- VI. A presentation on **Custody Outcomes in U.S. Cases Involving Abuse and Alienation Claims** was given by Joan Meier, Professor of Law, George Washington University Law School. Ms. Meier answered questions.
