Introductions of Nicholle Perras, interim ED of DVC, and of Isabel Checas No formal updates on the search for a new ED, paperwork is still pending with the county, but most things in Department are on hold due to the Omicron surge

2022 Legislative Process: Nancy presented on the 2022 state legislative process, including legislative deadlines. A copy of the PPT is attached herewith.

### State policies:

-Gov Newsom sets a budget with \$45B in excess funds. There is a request for \$50M for DV/SA that was not expressly included in this budget. The request will need to be supported by advocacy.

-Also note that redistricting was completed late last year, so there will be new districts, overlapping old districts, moving, retirements, etc. For example, Hertzberg will be running for Supervisor. The challenge is that having people and allies in place matter, if we lose our advocates, we have to start all over educating them. For more information, you can read about this issue in Politico, CalMatters and LAist. There will be a number of elections in 2022, including the June primary and November general. Later this year, we will talk about survivor voter participation, but expect 2023 to be about education of legislators.

- as to last year's 2 years bills that are still around, Carielle "volunteers' to research the status of the rent relief bill, FreeFrom will be invited to talk about the consumer bill, and work on the child welfare bill continues.

-Free Covid tests are available upon request – 4 per residential address, no immigration checks or insurance information required -VAWA has still not yet passed

Local policies

-City Report rom Chanel Smith: Budget meetings will begin in Feb. We requested level funding for DV and HT Shelter system, Survivor First, and the FJC Restraining order clinic. There was an increase to crisis to Shelter that is fully funded out of CDBG. This increase is due to the rise in hotel costs. In addition to the general fund, we are requesting funding for Survivor First out of CDBBT and Measure H to cover all of our bases and ensure ongoing funding.

-Nothing new to report from County, except that there are Covid testing updates and pick up tests are available from County.

New laws training will be offered on February 15, 2022

Julia says she submitted public comment on the paraprofessional issue, with many sign-ons
