Los Angeles Regional Policy Committee June 15, 2023 Meeting Minutes

#### 2023 Legislation & Policies

**State**: Budget deal has been reached and signed by the governor. Three budget topics: (1) DV prevention funding just not getting included in the budget, CPEDV, VALORUS and others are regrouping on 7/27 for a strategy call if you have interest in participating; (2) funding for proposed bill to raise the CalFresh minimum benefit to \$50 was included in the budget deal; (3) because the tax deadline was extended, state revenues for this year are unknown, so there is a possibility of a special session this fall to sort out funding.

Be aware of SB326 is a fast moving train to move mental health funding to homeless services. Pits child advocates against homelessness funding and takes away prevention funding. Will be discussed further on September (and will try to invite speakers from ACHSA and/or DMH) Get advocacy letters in now, will probably be a done deal by next meeting, but its moving fast without much opportunity for input and will rewrite mental health funding in CA.

**Federal:** Two Supreme Court matters will have impact on our constituents. At next session, Supreme Court will be considering the **Rahmini** case that found that abusers could not be denied guns merely because a restraining order had been issued against him. The Rahmini case only applies in the 5<sup>th</sup> Circuit (Texas and two other states) but a Supreme Court decision could apply the Rahmini case nationwide. NNEDV is collecting survivor stories involving guns as they prepare to opposition, please contact them with stories no later than August 4, Counterman is another impactful Supreme Court case decided last session, which offers First Amendment protections to threats made by a stalker.

**Loca**I: On July 11, 2023 the Board of Supervisors passed motion to direct LASD, LADA and DCFS to review policies and practices related to access to police

reports and other records; assess policies to assure adequate access to obtain certifications and strengthen training standards for certifiers; report back and also directs the Office of Immigrant Affairs to identify gaps in services for immigrant survivors of domestic violence, trafficking and other violent crime and report back with recommendations. DVC will be leading listening sessions in August, probably around the 3<sup>rd</sup> week.
