## DOMESTIC VIOLENCE COUNCIL (DVC) 2023 Year in Review

**KEY ACCOMPLISHMENTS** 

- 1. Return to in-person DVC General Membership and Committee meetings in May 2023.
- 2. Implemented hybrid DVC General Membership meetings in September 2023
- 3. Increased attendance from 40 to more than 100 by year.
- 4. Held annual breakfast, attended by more than 170 attendees; honoring 40+ agencies, 15 cochairs, 4 survivor activists.
- 5. Conducted 1:1 meetings with more than 50 key stakeholders to identify needs, gaps, and opportunities for DVC to improve response for LA County DV survivors.
- 6. Hosted 10 listening sessions with survivors, service providers, systems providers to address needs/gaps for immigrant/undocumented survivors.
- 7. Administered survey to access needs/gaps related to potential VOCA reductions.
- 8. Stood up DV and Child Maltreatment Workgroup in December 2023.
- 9. Stood up DV and African American Community Caucus Planning Committee in December 2023.
- **10**. Responded to 4 Board Motions related to DV.
- 11. DVC E Board/Co Chairs Retreat in December
