Los Angeles County Domestic Violence Council Meeting June 18, 2024







Gun Violence Prevention Platform (GVPP)

- OVP launched the GVPP in June 2022 following horrific deaths in Buffalo, New York and Uvalde, Texas, in addition to increased gun deaths and injuries in LA County including the Monterey Park mass shooting in January 2023.
- To develop a plan of action OVP established a Gun Violence Prevention Taskforce, comprised of over 30 community and county partners.
- The Taskforce identified **4 priority strategies** from a list of 40 strategies to prioritize to reduce gun violence.



Gun Violence Prevention Platform (GVPP)

- 1. Advocate for **robust gun safety legislation** locally and nationally, including the federal ban on assault weapons and large capacity magazines.
- 2. Promote social connections, healing, and a culture of peace through safe spaces and programs that address harm, trauma, and the impact of violence. Support opportunities that foster community togetherness, inclusion, and a sense of belonging while embracing diversity.
- In partnership with the courts, community and faith-based organizations, and law enforcement, improve awareness and access to Gun Violence Restraining Orders (GVROs.) Ensure services, systems and messaging are accessible, culturally relevant and cause no harm.
- 4. Increase access to comprehensive, culturally relevant physical and mental health supports and services for all students, K-12. Enhance school safety by implementing pilot initiatives in at least 3 school districts.



2023/2024 GVPP Highlights

- 1. 500 middle and high school students attended OVP's **5 Countywide Youth** Mental Health Summits that focused on elevating mental health literacy and resources for youth.
- Over 250 county and community partners received training on the Right Tool for the Right Situation including information about Gun Violence Restraining Orders and Domestic Violence Restraining Orders.
- 3. OVP, in partnership with DHS Medical Centers and LA County Libraries has launched a gun safety campaign and distributed over 7500-gun safety locks and educational materials.
- OVP, in partnership with the California Community Foundation, has invested \$5 million to increase access to comprehensive, culturally relevant physical and mental health supports and services for students, K-12 through School Safety Transformation Grants.

SCOPE

Starting Point: Decision to file petition for a DVRO

Ending Point: Final ruling on DVRO

In Scope: Journey to obtain a DVRO for identified personas; Legal, law enforcement, housing, child and support services touchpoints that are part of the DVRO process; Safety planning touchpoints; Data related to obtaining a DVRO; Barriers and issues to obtaining a DVRO; Identifying opportunities for improvement

Out of Scope: Enforcement of DVROs; Mapping identities separate from personas; Mapping systems outside of the DVRO process (i.e.- Homeless system); Deciding on solutions

OUTCOME/DELIVERABLE

- Construct a current state map of our persona's journey through the system to obtain a DVRO that depicts:
 - Steps, systems, roles, and flow through these system
 - Enabling and disabling experiences
 - Performance data (or placeholders)
 - Gaps and barriers to flow through these systems
- 2. Team identifies system gaps and barriers that can be improved.
- 3. Team gains a shared perspective on the end-to-end process to obtain a DVRO from the persona's perspective.

EXECUTIVE ORDER: SUSPENDING ENTRY OF NONCITIZENS

- Signed on June 4, 2024, to impose severe restrictions on the entry of noncitizens at the southern border.
- The Executive Order imposes a suspension and limitation on entry of noncitizens who cross the U.S. border between ports of entry and are apprehended by immigration officers within 100 miles of the southern border.
- Began on June 5, 2024, and will apply until 14 calendar days after there has been a consecutive calendar-day average of less than 1,500 encounters over a 7-day period. The suspension will continue to apply, or be re-implemented after it has been lifted, if there is a 7-day average of 2,500 encounters or more.
- During the Biden administration apprehensions have not fallen below this level.

EXECUTIVE ORDER'S EFFECT ON ASYLUM

The Executive Order includes an interim final rule from the Departments of Justice (DOJ) and Homeland Security (DHS) that restricts asylum eligibility for those noncitizens who enter outside of ports of entry along the southern border. The rule creates three key changes to the asylum process:

- 1. Individuals who enter the U.S. unlawfully along the southern border are ineligible for asylum unless they demonstrate that "exceptionally compelling circumstances exist";
- 2. DHS officers will no longer ask each noncitizen specific questions as to whether they have a fear of return and instead will only provide general information about the asylum process and refer a noncitizen for a credible fear interview (CFI) if the person affirmatively expresses a fear of return; and
- 3. During the CFI, an individual who establishes that they warrant an exception to the asylum restriction will be screened for a "reasonable probability of persecution," a higher credible fear standard than what is currently imposed.

PURPOSE OF PRESIDENT'S EXECUTIVE ORDER

- Increase the speed and consequences for those who cross our borders unlawfully or who attempt to present themselves at Ports of Entry without authorization.
- Limit the potential applicants allowed to remain in the U.S. and apply for asylum.
- The new rules do not apply for the following individuals:
 - 1. Unaccompanied children;
 - 2. People demonstrating exceptionally compelling circumstances, such as: an acute medical emergency; in imminent and extreme threat to life or safety (rape, kidnapping, torture, or murder);
 - 3. A victim of a severe form of trafficking; or
 - 4. People who use the CBP One application at a port of entry.
T-VISA NEW RULE

The Final Rule on T Visas published on April 30, 2024; Rule goes into effect August 28, 2024. Here are some of the new procedures that will be implemented through the Rule:

- 1. USCIS will conduct a bona fide determination (BFD) for T Visa applicants. If the applicant is found to be a bona fide applicant, they will be able to obtain an employment authorization document while their T-Visa application is pending a decision.
- 2. Extreme hardship to others besides the T-1 applicant may now be considered, but only if the T-1 applicant shows they would also suffer hardship because of the third party's extreme hardship.
- 3. Updated the definition of law enforcement agency (LEA) to include Tribal authorities and agencies with the authority to investigate or prosecute of trafficking under any administrative, civil, criminal, or Tribal laws.

NEW FEE RULE

- As of April 1, 2024, a new rule regarding government fees became implemented by U.S. Citizenship and Immigration Services (USCIS).
- For most applications or petitions submitted to USCIS, the fees paid to USCIS increased on April 1, 2024.
- However, for the vast majority applications submitted for survivor-based forms of immigration relief, such as the U-Visa, T-Visa, and VAWA, there is no longer a fee needed to submit the applications to USCIS.
 - This includes work permit applications and applications for a lawful permanent status.
 - Previously, many applicants were unable to pay the government fees or had to request a fee waiver to ask the government to waive the fee based on the applicant's inability to pay.

U-VISA BFD EMPLOYMENT AUTHORIZATION

- An employment authorization document (EAD) is issued by USCIS to bonafide U-Visa applicants.
 - USCIS issues a bonafide determination notice once a U-Visa applicant is eligible to receive an EAD.
- BFD EADs allow U-Visa applicants to lawfully work in the U.S. while USCIS is processing their U-Visa case.
- It is unpredictable when a client will receive a bonifide determination notice from USCIS
 - We are receiving BFD notices for cases we submitted between 2018-2023
