  - b. Any new examples of respondents being tipped off of DVRO filings before service, either by private attorney solicitation or sheriff deputies leaving request for contact?
    - i. Sheriff's deputies leaving request for contact during service attempt which station(s)? do they specifically say it's a DVRO?
    - ii. Private attorney solicitation pending possible legislative fix, interim safety planning ideas (leave respondent's address as unknown?)
    - $\rightarrow$  No updates
  - c. Call for other community experiences with law enforcement, prosecution, or the courts

→ Question posed by LAPD rep regarding pursuing firearm relinquishment but there is no proof of service: when restrained party does not appear for the return hearing and the final orders mirror those in the TRO with which the RP was served, judge will check box for service by mail – in theory LAPD could mail it themselves if the reviewing officer is willing (new FC 6383 makes it compulsory for a law enforcement officer to serve such orders at the request of petitioner or when reporting to a scene, but other times could be discretionary); best practices also include reminding petitioners to file a proof of service, as they may have had it mailed but failed to complete and file proof – should they be given a blank DV-250 with their DV-130 like they are given a blank DV-200 with their DV-110?

- b. CSI Legislative proposal priorities to present to LARP at their November meeting:
  - i. Amend RPC 7.3 to prohibit solicitation in DV cases
  - ii. Amend CRC 5.240 to include minimum number of hours of DV-specific training for Minor's Counsel, and define qualifications for providing those trainings
  - iii. Enact equivalent of FC 3044 in WIC to apply in dependency proceedings
  - → Update: also add request for new category of Sexual Assault Restraining Orders
- VII. Matters not on posted agenda to be presented and placed on a future agenda.
  - a. LAPD lethality assessment keep on agenda for January rollout
- VIII. Public Comments: not to exceed two minutes per person and must be on items of interest which are within the subject matter jurisdiction of the Council.
