- 1 in 3 people of all genders in the United States experience domestic violence in their lifetime, according to Doorways.
- 80 % of women with children who are experiencing homelessness were previously victims of domestic violence, according to the Institute for Children, Poverty and Homelessness.
- 57 % of all women experiencing homelessness stated domestic violence was the primary cause of their homelessness, according to Safe Housing Partnerships.
- 45 % of all domestic violence survivors had previously stayed with an abusive partner as a result of not having an alternative place to go.

OUR MISSION

New Directions for Veterans empowers men and women who served in the military, and their families, to lead productive and fulfilling lives.

Military Sexual Trauma (MST) 2004-PRESENT

- The Defense Department's attempts to reduce sexual assaults in the military have failed.
- Annual reports tracking numbers of actual assaults on women and men show that the problem is getting worse every year with no end in sight.
- The lower part of Figure, tracks completed cases filed by service members-only, shows that total numbers rose from 5,277 in FY 2017 to 6,053 in FY 2018.
 - A 15% hike in one year and a 146% increase since the 2,454 service-member cases reported in FY 2007.

Military Sexual Trauma (MST) 2021-Present

- The prioritization of force readiness above all else during the post-9/11 wars allowed the problem of sexual assault to fester.
- During and beyond the 20 years of the post-9/11 wars, independent data suggest that actual sexual assault prevalence is two to four times higher than DoD estimations.
 - DOD estimate that there were approximately 35,900 cases in 2021, and around 29,000 military personnel assaulted in 2023
 - Cost of War Project (Brown University's Watson Institute), reports 75,569 cases in 2021 and 73,695 cases in 2023.

DEPARTMENT OF DEFENSE- NUMBERS VERSUS COSTS OF WAR PROJECT

Sexual Assault in the Military: Estimates



The Costs of War Project: reports of sexual assault at the nation's three military academies rose more than 18% from 2021 to 2022.

IMPACT

- Many veterans who are victims of MST are not seeking services, and only about 30% of overall veterans use the VA healthcare.
- About half of woman who report Military Sexual Trauma have not used VA healthcare.
- Some barriers to women veterans seeking help for MST include:
 - The military culture and lack of supportive response to MST and Institutional betrayal.
 - VA facilities are mostly male, and many female victims of MST refuse to come on campus.
 - Resulting in less females applying for PSH housing on campus, and receiving the services they need.





ACLU Reports in 11-7-2013:

"The Department of Veterans Affairs grants disability claims for military sexual trauma-related PTSD at significantly lower rates than other PTSD claims, according to a new report released today. Women veterans are disproportionately denied compensation based on PTSD, as they are more likely to file MST-related PTSD claims, but male survivors who file MST-related PTSD claims face particularly low grant rates compared to female veterans who file MST-related PTSD claims."

QUESTIONS

- How can we get our victims to access their resources and benefits (increase trust)?
- What can we do to help victims of MST and DV at our sites on campus?
- How can we show that we take this seriously, so our victims feel safer while applying for permanent supportive housing?
- Is the team properly trained, to ensure we understand the police response on federal property?
- Do we know what to do when a victim is identified on campus for MST and DV?
 - Which facility would we refer any potential victims that reside on the West Los Angeles VA Campus?
 - Is this for veteran victims AND their family members!

SOLUTIONS

- Bring Sexual Assault and Domestic Violence Resources on the West Los Angeles VA Campus.
- NDVets created the Oasis for Woman's program, to try and give female veterans a safe place to start the process of recovery.

"To me, being at New Directions was like being in school. I learned a lot about myself. Once I understood the fact that I had a disease, it all made sense. I fell in love with the process of recovery – and I decided that I wanted to help others"

PERMANENT SUPPORTIVE HOUSING FOR VETERANS (PSH)

- Permanent supportive housing (PSH) for veterans is a program that combines affordable housing with supportive services to help homeless veterans achieve housing stability.
- PSH is a national best practice that's proven to be successful in keeping people housed. Some sources report that 85% of residents remain stably housed.
 - NDVets has over a 93% success rate at our PSH programs.
 - We have over 850 veteran units in operation, and over 200 veteran units in our pipeline.

Services

	Property Managements Responsibilities. Property Management (PM) is in charge of the daily oversite for MacArthur Field A. PM will take responsibility for day-to-day
Property	repairs and ongoing maintenance, security, and to ensure the upkeep of the Development is maintained.
Management (EAH)	PM will include screening potential tenants, drafting, signing, and renewing leases, collecting rent, addressing reasonable accommodations, and conducting eviction procedures when necessary. PM will follow the tenant selection plan, and ensure eligibility requirements are aligning with our funding sources requirements; for unit population and eligibility.
Lead Service Provider	NDVets Responsibilities. NDVets is the Lead Service Provider at MacArthur Field. NDVets shall be primarily responsible for providing service coordination for all veterans units. NDVets will ensure all veteran applicants on-site receive more than 28 enhanced services.
(ND Vets)	Resident Services Coordination and linkages to 3 rd party service partners, will be handled by NDVets service team on-site. NDVets partners with local service providers, to provide over 28 enhanced services to our residence. NDVets, GLA VA, Westside Food Bank, JVS SoCal, Inner City Law Center, AltaMed, and Resource Oversight and Guidance; will work in collaboration to ensure all residence get the services they need during the life of the project.
Veterans Affairs	U.S. Department of Veterans Affairs (VA) Greater Los Angeles Healthcare System (GLAHS). The VA, will be the lead case manager for the 74 VASH units, working in collaboration with NDVets supportive service staff.
HUD-VASH Program	Please note: New Directions now contracted by the VA to help serve VASH applicants. The VA has a wide range of resources for Veterans who are eligible for VA healthcare. Some of those services range from Intensive Case Management, Mental and Physical Healthcare, Medication Management, and Adult Day Care Services. NDVets supportive service staff will be providing or will refer to a 3 rd party, all enhanced services for the
